PART I

Privacy Policy

Effective Date: July 31, 2026

Taurus Advisory Group Inc. ("Taurus Advisory Group," "we," "us," or "our") respects your privacy. This Privacy Policy explains how we collect, use, disclose, retain, and protect personal information obtained through <https://www.tagcorp1.com> and related forms, communications, and services (collectively, the "Services").

By using the Services, you acknowledge the practices described in this Privacy Policy. If you do not agree with this Policy, do not submit personal information through the website.

1. Information We Collect

We may collect the following categories of information:

- **Contact information:** name, email address, telephone number, mailing address, company name, and professional or broker-related information you choose to provide.
- **Inquiry information:** subject, message content, requested appointments, questions, feedback, and related correspondence.
- **SMS consent records:** telephone number, the type of SMS consent selected, the disclosure shown, date and time, source page, submission identifier, and available technical evidence associated with the opt-in.
- **Technical information:** IP address, browser type, device information, referring pages, pages viewed, approximate location derived from IP address, cookies, and similar usage data.

Please do not submit Social Security numbers, banking information, medical information, consumer insurance applications, payment-card information, or other sensitive information through the general website contact form.

2. How We Collect Information

We collect information directly from you when you complete a form, contact us, request information, communicate with us, or separately opt in to receive SMS messages. We may also collect technical information automatically through website hosting, security, analytics, cookies, and similar technologies.

3. How We Use Information

We may use personal information to:

We may disclose personal information in the following limited circumstances:

Terms of Service
